Project activities will include training workshops, research and analysis, training on application and use of the framework, and stakeholder engagements on regional areas for SPS investments.
p th o to st p	The intended result for this project is to apply a variety of decision criteria to identify and prioritize available resources and improve application of SPS measures (acknowledging their potential to become barriers to trade) through development and implementation of improved regional framework related to SPS measures. This project is also intended to improve engagement and collaboration among SPS competent authorities towards strengthening of SPS frameworks. Additionally, the project will form a basis for donor programme coordination in identifying, funding, and managing national and regional SPS projects in the EAC.
st a co fa	The project has so far facilitated collaboration between SPS Competent Authorities and stake holders to present the P-IMA framework, and equip SPS experts with knowledge and skills needed to apply P-IMA. Analysis of regional SPS investment options has been completed. This analysis provides evidence to support ranking of investment options and facilitate inputs and strategic policy engagements with diverse stakeholders (for resource efficiency, demand-driven capacity-building and enhanced trade and social outcomes).
