We were wondering whether this would also apply to the Lots or just the sectors? Will we need to bid for specific lots and sectors?	Your submission and application should be per Lot as stipulated in the framework document. However, for each Lot you are required to specify the sector/s that your firm is strong.	Closed

FWA	ToR	Regarding the company registration eligibility criteria on Table 1 (page 14) in the ToR it is not totally clear what the options are and the extent to which you should register with one or more countries. Our company could either bid as an international entity with our local offices or we could bid as an African entity registered to one of the four African country offices where we are based. If we were to bid as one of our African entity country offices, would there be restrictions on our ability to draw from our track record beyond that office? Also, would you then only be able to bid for the regional lot that your office is based? Our preference would be for us to register as an international entity with our country offices listed so we can draw on your full team and track record.	Bidders are encouraged to place their bid with the entity that will be most suitable to them for doing business. The company registration is to determine where the firm is domiciled/registered. As a firm, you are open to bid for any of the lots as long as you demonstrate your capacity to deliver.	Closed
3.	FWA	ToR	In terms of the number of suppliers you include on the framework, you mention that there will be 10 suppliers on the framework. Would this be the overall maximum, or might you have up to 10 per sector?	The maximum number of 10 suppliers for shortlisting will be per Lot.	Closed

However, upon reviewing the document we noticed that South Africa is not part of the required leading partners mentioned on the Preliminary Requirements. kindly confirm if are we eligible to submit our bid documents.	This framework is open to all firms and not restricted to TMA operation countries. However, firms are required to demonstrate experience in the region/lot that they are bidding for in line with the terms of reference and evaluation criteria.	Closed
